## Santa Rosa Junior College Dental Programs

## Physical Examination/Immunization Requirements

Candidates who are accepted into the **dental assisting** program are required to submit the following documentation on **August 17, 2020** 

Candidates who are accepted into the dental hygiene program are required to submit the following documentation on August 18, 2020

- 1. Complete physical examination. You must use and submit SRJC Health Evaluation Form signed by physician or NP. Your physical must be completed within one year of entering the program.
- 2. Two (2) MMR vaccines or a positive serology report. For students born after 1956 only one MMR vaccine is required or a positive serology report. SRJC Student Health Services will provide this service for a fee for SRJC students.
- 3. New students are required to do a **2-step PPD** (TB test). Student must get 1<sup>st</sup> PPD between **June 1 and August 1** and get the 2<sup>nd</sup> PPD one to three weeks after the first one. This process has to be completed within one month in order to be a valid 2-step process, and **must** be completed prior to first day of class. SRJC Student Health Services will provide this service for SRJC students.
  - a. If PPD is positive, documentation of a baseline chest x-ray (radiology report) taken within the last year must be produced. A Symptom-Free Form completed by MD or FNP will need to be filled out one year after the chest x-ray. SRJC Student Health Services will order needed x-rays and perform the Review of Symptoms for SRJC students
- 4. Hepatitis B vaccine series in progress. This series is a five-month process. You **must** have 1<sup>st</sup> vaccine by the first day of school. The 2<sup>nd</sup> vaccine is administered one month later. The 3<sup>rd</sup> vaccine must be administered five months after the 2<sup>nd</sup>. SRJC Student Health Services will provide this service for a fee for SRJC students.
- 5. Tetanus-Diphtheria booster documented within the last 10 years. SRJC Student Health Services will provide this service for a fee for SRJC students.
- 6. Two (2) Varicella (Chickenpox) immunizations are required or a positive serology report.
- 7. Flu Vaccination current documentation of flu vaccination by the last day of October 2020 and annually thereafter.
- 8. Current BLS/CPR card including adult, child & infant, plus AED <u>accredited by American Heart</u> Association or American Red Cross.

You must provide **photocopies** of documents pertaining to the above for inclusion in your file in the Dental Programs. It is your responsibility to maintain copies for your own records. The **Dental Programs cannot make copies of your original documents for you**.

These required health documents must be turned into the Dental Programs on the dates listed above as all students are required to have dental procedures practiced on them by fellow classmates. This will begin the first week of school and continue throughout the program. Without this documentation, participation in clinical labs will not be allowed.

Documents submitted to the Allied Dental Programs become the property of the Program and may be disposed of at our discretion.
